Tuition Assistance is for tuition only and excludes library fees, books, lunch or other extracurricular activities.

If the financial status of the applicant changes during the school year, the finance committee reserves the right to alter the tuition assistance accordingly.

Student receiving tuition assistance must attend classes regularly, maintain good citizenship and maintain a minimum grade of C or higher in all subjects. In the event that a student receiving tuition assistance fails to maintain these standards, the finance committee of the board shall meet and review the continuity of the student in the program.

I understand that tuition assistance payments may not be posted to the students account until the family's portion has been paid.

All previous, outstanding balances held at Intermountain Adventist Academy must be paid in full before assistance will be awarded. In emergency situations written arrangements may be presented to administration and approved by the finance committee for past due balances. If any portion of the agreement is not satisfied, it is understood that the entire financial agreement may be terminated.

Any accounts more than 30 days past due will be assessed a monthly 5% interest on the unpaid balance. The finance committee will review accounts that are more than 45 days overdue. Affected students **may be suspended from classes** and extracurricular activities until satisfactory financial arrangements are approved.

Intermountain Adventist Academy reserves the right to withhold transcripts, grades and diplomas until student accounts have been paid.

I agree to abide by the schools Financial Agreement and understand that this is a binding financial agreement.

I understand that any deviation from this agreement does not constitute a change in the agreement, unless it is in writing and added as an addendum to this agreement.
